



Chick-fil-A Bowl Parade
Agreement, Release, and Waiver of Liability

In consideration of being permitted to participate in, or to assist others in participating in, the Chick-fil-A Bowl Parade (the "Parade") and related events (collectively with the Parade, the "Bowl Events"), and on behalf of myself, any organization I may represent, a minor child or ward of such organization, and all heirs, next of kin, personal representatives, successors or assigns of the aforesaid;

- 1. I ACKNOWLEDGE, UNDERSTAND and DECLARE THAT:
A. All minors or wards from my organization participating in the Parade or any other Bowl Event are at least 12 years of age or older on December 31, 2008;
B. To the best of my knowledge, I am in GOOD PHYSICAL CONDITION, and have no diseases or injuries that would be aggravated by participating in the Parade or any other Bowl Event;
C. To the best of my knowledge, all minors or wards from my organization participating in the Parade or any other Bowl Event are in good physical condition and have no diseases or injuries that would be aggravated by participating in the Parade or any other Bowl Event;
D. Participating, or assisting others in participating, in the Parade and the other Bowl Events may involve RISK OF INJURY TO ME, INCLUDING DEATH, LOSS OR DAMAGE TO ME OR MY PROPERTY, or other consequences which might result not only from my own actions, inactions or negligence, but also the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used;
E. Upon admittance into the Parade, I will receive a copy of the Chick-fil-A Bowl Parade Code of Conduct (the "Code of Conduct"). I understand that this Code of Conduct applies to all persons who are affiliated directly and/or indirectly with the Chick-fil-A Bowl as employees or volunteers, and I agree to comply with the letter and spirit of the Code of Conduct. Furthermore, I understand that this Code of Conduct is meant for my safety and well-being as well as the safety and well-being of others involved in the Chick-fil-A Bowl, the Parade, and the other Bowl Events;
F. There may be OTHER RISKS not known, or not foreseeable to anyone associated with the Parade or the other Bowl Events.
2. The owner of any animal(s) involved in the 2008 Chick-fil-A Bowl Parade, MUST INSURE THE PARTICIPATING ANIMAL(S) against any and all third party liability claims.

Notwithstanding the foregoing, I ASSUME ALL OF THE ABOVE RISKS, AND I RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS AND INDEMNIFY the Chick-fil-A Bowl, the City of Atlanta, the Metro Atlanta Chamber of Commerce, the Chick-fil-A Bowl sponsors, their respective affiliates, subsidiaries, predecessors, successors, related companies or businesses, and each of the aforesaid entities' respective officers, directors, employees, volunteers, participants, agents, and/or representatives (legal or otherwise), from any and all claims or liabilities arising out of injuries (including death), loss or damage to personal property, or any other consequence relating directly or indirectly to my participation in, or my activities with, the Bowl Events, including travel to and from the Bowl Events or any event related to the Bowl Events, including without limitation, the Chick-fil-A Bowl football game.
5. I agree that I will allow my photograph, picture or likeness and/or voice to appear in any official documentary, promotion (including any and all advertisements), television, radio or film coverage of the Chick-fil-A Bowl football game and the Bowl Events WITHOUT COMPENSATION.
